#### **COMPLAINT**

1. Allerton Charter Coach, Inc. ("Allerton Charter"), a motor carrier of passengers operating in charter service in and around the Champaign-Urbana, Illinois, area, hereby files this Complaint against the Champaign-Urbana Mass Transit District ("MTD") for ongoing violations of the Federal Transit Administration ("FTA") charter service regulations, 49 C.F.R. Part 604. Allerton Charter seeks an order enjoining MTD from providing the charter service in question in the future, debarment of MTD from receipt of further financial assistance from the Federal Transit Administration, and damages for lost profits for service that Allerton Charter would have provided except for such violations.

#### THE PARTIES

- 2. Allerton Charter is a corporation organized under the laws of the State of Illinois. It is lawfully engaged as a motor carrier of passengers in the private business of providing charter and other passenger transportation services by bus in and around the cities of Champaign-Urbana, Illinois. Allerton Charter is located at 313 East Green Street, Champaign, Illinois 61820, which is within the urban district where MTD is authorized to provide bus service. Allerton Charter has four 47-passenger buses currently available for intrastate charters, and in the past has operated as many as six buses in charter service.
- 3. MTD is a recipient of financial assistance under the Federal Transit Act within the meaning of 49 C.F.R. §604.5(l) and is engaged in providing mass transportation services in and around the cities of Champaign-Urbana, Illinois.

#### CHARTER SERVICE REGULATIONS

- 4. "Charter service" is defined in 49 C.F.R. §604.3(e) as "transportation using buses ... of a group of persons who pursuant to a common purpose, under a single contract, at a fixed charge . . . for the vehicle or service, have acquired the exclusive use of the vehicle or service to travel together under an itinerary either specified in advance or modified after having left the place of origin."
- 5. The FTA charter regulations at 49 C.F.R. §604.9(a) provide that if a recipient of FTA funds "desires to provide any charter service using FTA equipment or facilities, the recipient must first determine if there are any private charter operators willing and able to provide the charter service which the recipient desires to provide." In order to determine if there are any private charter operators willing and able to provide the service that the recipient desires

to provide, the recipient must complete a "public participation process" at least 60 days before it desires to begin providing charter service. As set out in 49 C.F.R. §604.11(b), the public participation process requires, at a minimum:

- (a) Placing a notice in a newspaper of general circulation within the proposed geographic charter service area;
- (b) Sending a copy of the notice to all private charter service operators in the proposed geographic charter service area and to any private charter service operator who requests notice; and
- (c) Sending a copy of the notice to the headquarters of the American Bus

  Association, Inc. and to the United Bus Owners of America, Inc., two private bus industry trade associations.
- 6. The FTA regulations also contains specific requirements for the contents of such notice, and must allow any private charter operator desiring to be considered willing and able at least 30 days from the date of the notice to submit written evidence to prove that it is willing and able to provide the charter service that is the subject of the notice. 49 C.F.R. §604.11(c).
- 7. The FTA charter regulations also state that to "the extent that there is at least one such private operator [willing and able to provide the desired charter service], the recipient is prohibited from providing charter service with FTA funded equipment or facilities unless one or more of the exceptions in §604.9(b) applies."

#### CHARTER SERVICE NOTICE AND RESPONSE

8. On March 3, 2003 Dennis Toeppen, President and Owner of Allerton Charter, notified MTD that Allerton Charter was available to provide charter bus service in the

Champaign-Urbana market. This notification was made by electronic mail from Mr. Toeppen to William L. Volk, Managing Director of the MTD.

- 9. On March 20, 2003 Mr. Volk of the MTD responded by electronic mail to Mr. Toeppen that "Each year in June," the MTD "solicits the local charter bus community to determine if there are any 'willing and able' charter operators." The response noted that in the past only one private operator, Illini Swallow, has responded to the solicitation, and that the MTD "entered into an agreement with Illini Swallow to provide charters in the Champaign-Urbana area since [Illini Swallow] did not have the capacity to operate the charters on their own." A copy of the electronic mail correspondence is attached hereto as Exhibit A.
- 10. On June 3, 2003 the MTD sent a Notice of Intent to provide charter service to Allerton Charter. A copy of the Notice is attached as Exhibit B hereto. The Notice stated that the MTD "shall not provide any charter service using equipment of facilities funded under the UMTA Act of 1964 as amended to the extent that there is at least one willing and able private charter operator unless the recipient qualifies for one or more of the exceptions in 49 CFR Section 604.9(b)." The Notice was authorized by William L. Volk of the MTD.
- 11. On July 9, 2003 Mr. Toeppen responded to the Notice by certified mail return receipt requested. The response indicated that the Notice failed to meet regulatory requirements in 49 C.F.R. §604.11(c) because it failed to state the categories of revenue vehicle involved or provide the address to which the evidence that the private operator is willing and able must be sent. A copy of the response is attached as Exhibit C hereto. Despite these omissions, the response stated that Allerton Charter was willing and able to provide charter bus service in the Champaign-Urbana district.

12. Although the Notice of Intent was undated and was not received by Allerton Charter until June 3, 2003, the Notice stated inaccurately that the MTD would "review only the evidence submitted by July 23, 2002." The Notice further stated that the MTD would complete its review of the evidence submitted by willing and able private bus operators within 30 days of "that date," and would inform each private bus operator of the results of the review within 60 days of "that date." Allerton Charter never received any response indicating that the MTD had reviewed the evidence submitted by Allerton Charter or the results of any such review.

#### CHARTER SERVICE

- 13. Notwithstanding the clear response to the Notice that Allerton Charter was willing and able to provide charter bus service, the MTD has continued to offer and provide charter bus service on an ongoing basis in violation of 49 C.F.R. §604.9(a).
- 14. Attached hereto as Exhibit D is a collection of some 75 "Special Service Contracts" for charter bus service provided by the MTD in the period after Allerton Charter informed the MTD that Allerton Charter was a willing and able private charter bus operator. These charter contracts were for service performed between June 21, 2003 and April 14, 2004. The total value of the charter contracts was \$32,256.50, which does not include some six charters that were provided at no charge to the customer. This charter service was operated in direct violation of the charter service regulations in 49 C.F.R. Part 604.
- 15. The service referenced in these agreements contained in Exhibit D clearly meets the definition of "charter service" in 49 C.F.R. § 604.3(e). The service is pursuant to a contract with a single entity, to transport persons pursuant to a common purpose to a single destination. The service is provided at a fixed hourly charge per bus, and individual passengers are not charged any fare. Furthermore, the service is controlled entirely by the contracting customer. In

each case the customer sets the itinerary when the service is ordered in advance, and obtains the exclusive use of the vehicles for the period of the service. The MTD has not incorporated this service into its scheduled transit service and has not advertised or published the service in its public schedules. Moreover, none of the exceptions set out in 49 C.F.R. § 604.9(b) apply to this service.

- Intent, the MTD continued to provide charter bus service for work that had been contracted for prior to receiving the response from Allerton Charter. Exhibit E hereto is a copy of electronic mail correspondence between Mr. Toeppen of Allerton Charter and Mr. Volk of the MTD regarding the use of an MTD bus for a charter by the Illinois Crop Protection Technology Conference on January 7, 2004, some five months after Allerton Charter responded to the Notice and ten months after Allerton Charter first notified the MTD that Allerton Charter was willing and able to provide charter bus service. Mr. Volk's response indicated that the MTD had "not accepted any new charter orders since mid-November." He made no reference as to why mid-November was an appropriate date to stop accepting new orders. Mr. Volk also stated that the MTD "continues to 'run out' charter orders [it] committed to and where contracts were in place prior to mid-November."
- 17. There is nothing in the charter service regulations that allows a recipient of federal funding to provide charter bus service that was booked before receiving a notice of a willing and able private operator if the service is to be provided on a date after receipt of such notice, however. The regulations state plainly that "[t]o the extent that there is at least one private operator, the recipient is prohibited from providing charter service with FTA funded equipment or facilities unless one or more of the exceptions in §604.9(b) applies." 49 C.F.R.

- §604.9(a). The regulations do not state that the recipient may provide such service if it is already booked despite the existence of a willing and able private operator, and the FTA may infer no such allowance in its policies or remedies.
- 18. The MTD apparently continues to provide charter service is flagrant violation of the Part 604 regulations. On May 7, 2004 Mr. Toeppen observed an MTD bus with "MTD Special" on the destination sign parked in front of a local radio station. When he called the radio station office, he was informed that the bus had brought a load of students to the station for a tour. Mr. Toeppen sent a written inquiry to the MTD about the nature of this service, see Exhibit F hereto, and Mr. Volk responded on May 18, 2004 that this was a tour for a school group. Mr. Volk's response stated that "Illini Swallow was contacted for this no-cost trip and indicated it had no available equipment." *Id*.
- 19. The MTD response indicates two further incorrect assumptions about the charter regulations. First, if one private operator is contacted about a charter move but has no available equipment, it may not subcontract the move or otherwise offer it to a recipient of federal transit funds if there is another willing and able private operator. The language quoted in paragraph 17, above, plainly states that a recipient may not provide charter bus service if there is "one private operator" that is willing and able to provide the service. Regardless of whether the first private operator has no available equipment, the MTD may not provide *any* charter service as long as Allerton Charter is willing and able to provide the service, unless one of the other regulatory exceptions applies.
- 20. Second, it does not matter for purposes of the charter regulations whether the service is provided at no charge to the customer. A recipient of federal funds may not provide

any charter bus service, whether or not it is revenue-generating, if there is a single willing and able private operator unless one of the regulatory exceptions applies.

#### INTERVARSITY CHRISTIAN FELLOWSHIP SERVICE

- 21. Attached hereto as Exhibit G is a letter agreement dated December 22, 2003 between the MTD and the Intervarsity Christian Fellowship ("IVCF"). The agreement is to provide charter bus service during the Urbana 2003 Missions conventions to be held between December 26, 2003 and January 1, 2004. Although the agreement refers to the IVCF using MTD "routes" during this period, the agreement also states that the MTD will "supplement existing routes" to meet the needs of the IVCF. In fact, the service was run between the University of Illinois Assembly Hall and the University of Illinois dormitories at the direction of the charter service customer. Although the service might have been nominally open to the public, few if any non-IVCF attendees used the service as the university dormitories were otherwise closed for the winter break. The value of the service provided under the agreement was \$155,000.
- 22. The IVCF service was not "mass transportation" because it did not meet the requirement in the definition of mass transportation in 49 U.S.C. §5302(a)(7) that such service be "regular and continuing" service. The IVCF convention occurs only once every three years for a period of one week. The FTA has recognized that service to an event that occurs only once a year is not regular and continuing and therefore is not mass transportation. See Kemps Bus Service, Inc. v. Rochester-Genesee Regional Transportation Authority, Decision of Regional Administrator (September 18, 2002). In that case the Regional Administrator's opinion held that service to a professional golf tournament held one week a year was not mass transportation,

stating, "Unlike mass transportation, this service is not provided on a regular and continuing basis. It operates only one week a year when the golf tournament is in session." *Id.*, at 5.

- The MTD may use federal funding only for mass transportation projects, see, e.g., 49 U.S.C. §5307(b)(1) (urbanized area formula grants for use in mass transportation). The Federal Transit Act defines "mass transportation" as "transportation by a conveyance that provides regular and continuing general or special service to the public, but does not include schoolbus, charter or sightseeing transportation." 49 U.S.C. §5302(a)(7). If transit agency service fails to meet the definition of mass transportation, then the service is not eligible for federal funding, regardless of whether the service meets the charter service definition.
- 24. The IVCF service was charter service because it was controlled by the customer, was not truly open door service, and was subject to a single contract. Moreover, the service clearly did not meet the definition of mass transportation and is therefore prohibited under FTA funding restrictions.

#### CONTINUING PATTERN OF VIOLATION OF THE CHARTER REGULATIONS

- 25. In addition, the MTD's illegal charter operations are not a one-time aberration, but part of a concerted effort to develop a substantial and viable charter operation as a separate profit center for the transit operator. The MTD is holding itself out to the public as a charter bus operator, without complying with the public participation process set out in 49 C.F.R. § 604.11. Although the MTD has been put on notice that Allerton Charter is a willing and able private charter bus operator, the MTD continues to offer and provide charter bus service in violation of the FTA regulations.
- 26. Based on the foregoing, it is clear that the MTD has embarked on a course to increase its charter service operations in direct competition with private charter operators and

with no regard for the FTA charter service regulations. The MTD has established a continuing pattern of violation of the charter regulations, and gives no indication of any willingness to be bound by such requirements.

#### DAMAGES \(\)

26. Because the MTD has violated the FTA charter service regulations, Allerton Charter has suffered economic harm through loss of profits. According to the purchase orders set out in Exhibit D hereto, the MTD provided charter service after receiving notification that Allerton Charter is a willing and able participant amounting to \$32,256.50. In addition, the IVCF charter service was valued at \$155,000. Because Allerton Charter is apparently the only private bus operator that is willing and able to provide charter service in the Champaign-Urbana market, Allerton Charter would have contracted for this service if not for the violations of the MTD.

WHEREFORE, Complainant Allerton Charter respectfully requests that the Regional Administrator:

- (a) Declare that the MTD has engaged in a continuing pattern of violations of the FTA charter service regulations in 49 C.F.R. Part 604;
- (b) Order the MTD immediately to eease providing prohibited "charter services" and otherwise to comply with the requirements of 49 C.F.R. Part 604, regardless of whether such charter service has already been booked or contracted for by the MTD;
- (c) Order the MTD to pay to the Complainant compensatory damages in the amount of \$187,256.50, plus interest;

- (d) Bar the MTD from the receipt of further financial assistance for mass transportation facilities and equipment under 49 C.F.R. §604.17(b);
- (e) Tax the costs of this complaint proceeding, including reasonable attorney's fees, against the MTD; and
  - (f) Grant such other and further relief as may be just and necessary.

#### RE: CHARTER SERVICE

The Champaign-Urbana Mass Transit District proposes to provide the charter service described as follows:

- 1. Serving within the boundaries of the Champaign-Urbana Mass Transit District.
- 2. Service available 24 hours a day, seven days a week.

Any private operator desiring to be considered willing and able to provide the above listed service must submit written evidence to the Champaign-Urbana Mass Transit District, 801 East University Avenue, Urbana, IL., 61802, that:

- 1. The private operator, has the desire and physical capability to actually provide the categories of revenue vehicles specified.
- 2. The private operator has the requisite legal authority to provide the proposed charter service.
- The private charter operator meets all necessary safety certification, licensing, and other legal requirements to provide the proposed charter service.

The District shall review only the evidence submitted by July 23, 2002; shall complete its review within 30 days of that date; and within sixty days of that date shall inform each private operator of the results of the review.

The Champaign-Urbana Mass Transit District shall not provide any charter service using equipment or facilities funded under the UMTA Act of 1964 as amended to the extent that there is at least one willing and able private charter operator unless the recipient qualifies for one or more of the exceptions in 49 CFR Section 604.9(b).

I am in receipt of your memo entitled "Notice - Charter Service" which you sent me attached to a letter dated June 3, 2003.

Please note that your notice does not comply with the requirements of 49 CFR Section 604.9(b) because it fails to state the "categories of revenue vehicle", nor does it "state the address to which the evidence must be sent".

In spite of your material omissions, I am submitting written evidence stipulated in your notice, as indicated below:

# "1. The private operator has the desire and physical capability to actually provide the categories of revenue vehicles specified."

I hereby advise you that Allerton Charter Coach, Inc. has the desire to "provide the categories of revenue vehicles specified". To facilitate entry into the charter business, we have purchased a phone line and set up a web page at www.allertoncharter.com (printout attached).

Allerton Charter Coach, Inc. owns a fleet of 47 passenger buses. These buses can be used to carry small groups (ie less than 47 passengers), as can MTD mini-buses, and they can be used to carry large groups (ie greater than 47 passenger), as can MTD full-size buses and articulated buses. Unlike MTD buses, however, Allerton buses are also equipped with restrooms and luggage compartments, which can be used by Allerton customers at no additional charge.

Since Allerton has the ability to serve the same set of customer needs as MTD, we assert that we have the "physical capability to actually provide the categories of revenue vehicles specified".

I have attached photocopies of several vehicle titles as evidence that we possess equipment with which to operate charter service.

Both conditions of this part have been met.

# "2. The private operator has the requisite legal authority to provide the proposed charter service."

Pursuant to 625 ILCS 5/19c-6102 (attached), Allerton Charter Coach, Inc. is not subject to the regulatory authority of the Illinois Commerce Commission. Since Allerton Charter Coach, Inc. does not operate outside the State of Illinois, it is not subject to any other jurisdictions. Allerton Charter Coach, Inc. therefore possesses the requisite operating authority to provide charters within the State of Illinois.

"3. The private charter operator meets all necessary safety criterion, licensing, and other legal requirements to provide proposed charter service."

Allerton Charter Coach, Inc. buses are subject to state inspection twice a year. Each bus has a state inspection sticker evidencing such inspection. If MTD wishes to visit Allerton garage to verify inspection status of its vehicles, you are welcome to make an appointment to do so.

Allerton Charter Coach, Inc. buses are equipped with proper license plates issued by the State of Illinois. Were they not, they would not be permitted on the roadway.

Allerton Charter Coach, Inc. buses are properly insured. A copy of the declarations page of the current insurance policy is attached.

This evidence is being mailed certified mail return receipt requested this date, and hand delivered to 801 E University on July 10, 2003.

As a result of this submission, we expect that MTD will cease and desist the practice of offering and operating charter service in Champaign-Urbana.

This will serve as an Agreement between the InterVarsity Christian Fellowship (IVCF) and the Champaign-Urbana Mass Transit District (District).

IVCF desires to use District regular routes during its Urbana 2003 Missions Convention. Since existing route service does not contain enough capacity to meet Urbana 2003 needs, the District will supplement established routes to meet those needs. The District, in addition to supplementing existing routes, will set times of operation of all routes and all routes will be publicized and open to the general public. Routes will be in operation between 12/26/2003 and 01/01/2004, inclusive.

The District will honor the Urbana 2003 identification bracelet and regard it as a District bus pass, when presented by Urbana 2003 participants to District agents and bus operators. IVCF agrees to pay the District \$155,000 for up to 20,000 participants for such passes. IVCF agrees to pay half of this amount prior to the commencement of service and the balance by 01/30/2004.

As a result of the needs of the disabled attending the conference, all vehicles operated will be accessible by either ramps or lifts.
